## Subject: URGENT DRUG RECALL

Drugs Manufactured by Astral SteriTech Pvt. Ltd. and Distributed by Civica, Inc., Meitheal Pharmaceuticals, Piramal Critical Care, and Xellia Pharmaceuticals

Dear Customer,

This letter is to inform you that Astral SteriTech Pvt. Ltd. (Astral) is initiating a voluntary recall of all products manufactured at its facility in Vadodara, Gujarat, India that are still within expiry as of the date of this letter. These affected products are sterile antibiotic powders for injection that were manufactured between May 2020 and April 2023. These products were distributed by and labeled in the names of the following distribution partners: **Civica, Inc., Meitheal Pharmaceuticals, Piramal Critical Care, or Xellia Pharmaceuticals**. Please refer to the **Appendix** for a complete list of affected products, including NDC numbers.

#### **Reason for Recall**

The recall is being initiated due to quality concerns Astral identified while investigating out-ofspecification results in environmental monitoring at its manufacturing facility. Because of these concerns, the sterility of products manufactured at Astral's facility cannot be assured.

To date, Astral has not received reports of adverse events relating to this issue. Intravenous or intramuscular administration of a product for which sterility cannot be assured could result in serious systemic infections. Further distribution or use of these products should cease immediately.

#### **Requested Actions**

Please take the following actions to implement this recall.

- 1. Immediately examine your inventory, discontinue use, and quarantine all recalled products.
- Complete <u>both pages</u> of the enclosed "Recall Response Form / Packing Slip" and email to <u>astralsteritech8451@sedgwick.com</u> or fax to 1-888-345-4261 as soon as possible. Please return the response form even if you do not have any inventory in your possession.

- 4. We will contact these accounts or locations directly with instructions for returning affected product.
